One of the things I find to be very helpful when lawyers are involved in he mediation is to chat with them separately, before the mediation, about their role and how they see themselves participating, whether they anticipate speaking on behalf of their client or letting their client take the lead. If I sense resistance, I gently share with them how important it is for their client to be/feel heard, directly. It is not unusual for these attorneys to be the ones expressing surprise and positivity at the end of the mediation about the process and its success.

Years ago, I mediated a small claims case between two neighbors. The plaintiff was seeking reimbursement of veterinarian expenses for treatment of their dog who was stabbed by the defendant. I tried to cause skepticism about the likely outcome in court by wondering what the commissioner would rule if he happened to be a dog owner. The defendant confidently replied that he was trained to use a knife and in fact knew how to kill an animal with a knife. He was going to point out that though he could have killed the dog, he simply was trying to injure it for coming on to his property. I used to think that as a psychologist, I heard some pretty interesting stories. This mediation case changed everything. The most interesting stories happen in mediation.
