#### **CANDIDATE BIOGRAPHIES**

## **Melissa Appleton**

Melissa manages the implementation of Participatory Budgeting projects and innovations on the East Coast. With over eight years of experience supporting group and inter-personal dialogue as a facilitator, mediator, and trainer at the largest community mediation organization in the US (New York Peace Institute), she brings a passion for collective decision-making to participatory budgeting. Melissa is happy to be supporting group deliberation with diverse communities more locally after doing conflict resolution work internationally in Timor-Leste, Kosovo, and Israel. She received a graduate degree in Peace Education from Columbia University and, though a proud Vancouver native, has called New York City home for over 11 years. Melissa also served as a co-chair for the 2016 ACR-GNY Annual Conference.

### Theo Cheng

Theo Cheng practices in intellectual property and general commercial litigation. He heads the firm's Trademarks and Unfair Competition Practice and also focuses on copyrights, patents, trade secrets, and other intellectual property matters. With 20 years of experience handling a broad array of business disputes in federal and state courts, Mr. Cheng counsels high net-worth individuals and small to middle-market business entities in industries as varied as high-tech, telecommunications, entertainment, consumer products, fashion, food and hospitality, retail, and financial services. He typically formulates and advises clients and their in-house counsel on litigation and dispute resolution strategy, often striving to suggest innovative and creative ways to resolve conflicts. Mr. Cheng is also a Trustee of the Copyright Society of the U.S.A. and serves as the Co-Chair of its New York Chapter. In 2007, he was named one of the Best Lawyers Under 40 by the National Asian Pacific American Bar Association. He is licensed to practice in both New York and New Jersey.

Mr. Cheng is also an arbitrator and mediator with the American Arbitration Association (AAA), the CPR Institute, Resolute Systems, and several federal and state courts, principally focusing on intellectual property, entertainment, and technology disputes. He was also appointed to the Silicon Valley Arbitration & Mediation Center's 2016 List of the World's Leading Technology Neutrals. As a neutral, Mr. Cheng has conducted over 325 arbitrations and mediations, resolving commercial and business disputes, breach of contract and negligence actions, trade secret theft, employment discrimination claims, wage-and-hour disputes, and intellectual property infringement contentions. He received a 2013 AAA A. Leon Higginbotham, Jr. Fellowship and serves on the Council of the AAA and the Board of the Justice Marie L. Garibaldi American Inn of Court for ADR. He is also a member of the New Jersey Association of Professional Mediators and serves on the New Jersey Supreme Court's Arbitration Advisory Committee and the Committee on Complementary Dispute Resolution.

Mr. Cheng received his A.B. cum laude in Chemistry and Physics from Harvard University and his J.D. from New York University School of Law, where he served as the editor-in-chief of the Moot Court Board. Before joining the firm, he was a senior litigator at several prominent

national law firms. He was also a marketing consultant in the brokerage operations of MetLife Insurance Company, where he was designated a Chartered Life Underwriter and Chartered Financial Consultant, as well as a Series 7 General Securities Representative. Mr. Cheng served as a law clerk to the Honorable Julio M. Fuentes of the U.S. Court of Appeals for the Third Circuit and the Honorable Ronald L. Buckwalter of the U.S. District Court for the Eastern District of Pennsylvania. He is a member of several bar and professional associations, for which he serves on various litigation, intellectual property, and ADR sections and committees. He is currently co-chair of the Mediation Committee of the New York State Bar Association's Dispute Resolution Section and a Trustee of the New Jersey State Bar Association's Dispute Resolute Section. He frequently writes and speaks on ADR and intellectual property issues.

#### Aldo Civico

I have 25 years of experience in conflict resolution and peacebuilding. At the outset of the 1990s, I moved from my hometown Trento, in Northern Italy, to Palermo, to join the anti-mafia social movement. In the years that saw the assassinations of prosecutors Giovanni Falcone and Paolo Borsellino, I worked alongside the mayor of Palermo Leoluca Orlando, to make strategic community building the cornerstone for social change. In 2000, after working for a few years as a free lance journalist for German media, I moved to New York where I joined the Center for International Conflict Resolution (CICR) at Columbia University under the mentorship of Andrea Bartoli. Subsequently, from 2007 to 2010 I became the director of CICR where I led the efforts to transform conflict resolution from a program into a specialization for SIPA graduate students

Since 2001, as a researcher and a practitioner, I have been involved in peacebuilding in Colombia. I conducted challenging fieldwork among members of paramilitaries death squads as well as internally displaced people, and in 2015 I published the book The Para-State: An Ethnography of Colombia's Death Squads. Between 2005 and 2008, I have facilitated ceasefire talks between government of Colombia and the guerrilla of the National Liberation Army (ELN). I am still involved in the ongoing efforts. Furthermore, in the past few years, as an associated researcher at the Advanced Consortium on Cooperation, Conflict and Complexity, I have focused my efforts on brining the principles and strategies of conflict resolution to urban areas marked by violence, designing with my colleagues at Columbia University trainings for youth and community leaders, and advising public official in conflict resolution sensitive policies.. In New Jersey, I have been helping leaders in the public and private sector to develop approaches that support the reintegration of ex-offenders.

It will be an honor and a pleasure to bring my international experience to benefit the great work that ACR-GNY has being doing, especially at a time when our country needs to find spaces for dialogue and reconciliation, and where the predispositions and attitudes rooted in conflict resolution are most needed. Given my experience, I will be happy to focus especially on how our organization can work with the City of New York in adopting ADR processes to resolve conflict and increasing dialogue with the communities, and how we can increase the conflict resolution capacity building of youth leaders especially in areas marked by violence. I am grateful and most honored for this nomination.

## **Charlotte Ramsey**

I was raised in Rockland County, New York, a working class suburb of NYC. After graduation from high school I attended The American University in Washington, DC to study mass communications and graduated with a BA. I hold a Masters Degree from Teacher's College, Columbia University in Organizational Psychology and a Juris Doctor degree from Temple University.

## Regina Ritcey

Regina Ritcey is the Director of Mediation Services at Community Mediation Services (CMS), in Jamaica, New York. Prior to joining CMS--the Community Dispute Resolution Program for Queens County--Regina served for six years as a staff mediator with the New York City Family Court's Child Permanency Mediation Program, mediating child welfare cases. A seasoned mediation practitioner and dispute resolution program administrator, Regina has extensive experience developing and managing community-based, court-connected, and commercial mediation programs. She has extensive mediation training design and delivery experience, and has managed a variety of programs involving staff, volunteer, and contract mediators.

Ms. Ritcey began her mediation career over 25 years ago working as a mediator and program manager with a Victim Offender Reconciliation Program in Oakland, California. In addition to working with court-connected youth, Regina worked with a victim offender program in San Quentin and other prisons in California. Regina later worked as a Tribunal Administrator and Program Manager for California Community Dispute Services, a community mediation program in San Francisco and as a Hearing Officer for the City & County of San Francisco. She went on to manage the mediation services of the American Arbitration Association (AAA) in San Francisco where she managed daily program operations of the commercial mediation division and designed and delivered mediation training programs for AAA staff and mediators.

Ms. Ritcey's mediation work has included involvement in the San Francisco Bar Association's ADR Committee, the New York City Bar Association's ADR Committee, and numerous working committees, and panels. Notably, along with two fellow NYCBA ADR members, Ms. Ritcey and her colleagues designed and presented the New York Surrogate's Court mediation training program.

Ms. Ritcey's mediation specialties and advanced trainings include victim offender mediation, child permanency, divorce and family mediation. She earned a J.D. in 2002 from the University of San Francisco School of Law, where she was the Literary Editor of the USF Maritime Law Journal and a Public Interest Law Scholar, clerking for the U.S. Department of Justice Environment and Natural Resources Division. # Dana Berman, Director at Large

Dana Berman is the Assistant Director of CLE at the New York City Bar, where she is a key player in developing a continuing legal education (CLE) program for a leading bar association that offers approximately 150 courses annually in a broad range of practice areas including litigation, mediation, arbitration, negotiation, ethics, and legal writing. Dana's responsibilities include planning and implementing annual multi-day mediation trainings, which entails recruiting the lead trainers and role-play coaches and obtaining New York State Unified Court System approval qualifying trainees for court mediation panels. She was a member of the City Bar's Alternative Dispute Resolution committee for ten years.

Dana served as a Consultant to plan ACRGNY's Twelfth Annual Conference held in June 2013, in collaboration with the Conference Co-chairs and Board of Directors. Previously, Dana was the Director of Mediation at the New York Center for Interpersonal Development where she managed the day-to-day operations of a Community Dispute Resolution Center Program operated under the auspices of the Unified Court System and oversaw mediation and arbitration processes and community outreach. Prior to that, she was an Associate Attorney at the law firm Carrieri & Carrieri, P.C.

Mr. Newman has served as facilitator or coach at various continuing legal education programs on mediation, including advanced trainings. He has been a volunteer judge of various law school and graduate school negotiation and dispute resolution competitions and examinations.
